There are 27 homes in Stroud District: 13 residential homes offering a total of 343 beds and 14 nursing homes offering a total of 702 beds.</p> <p>GCC currently has 7 contracts with Extra Care facilities; in 3 of these we have a respite flat in order to promote Housing with Care.</p> <p>In addition to the above are Home Care arrangements relating to Hospital Discharge. There are two Hospital 2 Home contracts, and 3 guaranteed hours’ arrangements to deliver home care in rural Gloucestershire, Tewkesbury, Stroud District and Forest of Dean District. There are 82 providers delivering against the current Home Care DPS (Dynamic Purchasing System) and Disabilities frameworks.</p>

That's why it is important to act quickly, and to focus on early engagement with residents and staff.

<p>Agenda Item 7: Delivery of Structural Maintenance Works 2020-2022</p> <p>On 15 May 2019, this Council unanimously passed a climate action plan, which amongst other resolutions committed the council to:</p> <p>“Consider its contracts going forward to oblige all contractors to report their carbon emissions and to place a ‘carbon/environmental cost’ on competing bids.”</p> <p>Can the Cabinet Member please confirm that the procured contractor will be obliged to report its carbon emissions, and clarify how GCC will apply a carbon/environmental cost in the competing bids?</p>	<p>The council will deliver our commitment to slash carbon emissions – building on our success to date in doing so with projects like our LED street lighting programme. In this case, we are continuing to work with partners, both within Gloucestershire and across the industry, such as the South West Highways Alliance and the Chartered Institute of Highways and Transportation, to consider how best to capture and report carbon emissions and carbon/environmental cost in future contracts but at present we are not aware of any standardised methodology for doing this across the highways industry which enables either benchmarking or demonstrating neutrality across organisations. One of the reasons this contract is only for two years is to allow for a future contract to be more specific on carbon factors.</p>
