Map No. 7.—That part of footpath CST.5 in the Parish of Stinchcombe shall be deleted from the map from its junction with CST.4 north-east of Tait's Hill, north-east to the point where it joins footpath CCA.10 at the Parish Boundary with Cam.

Map No. 6.—That footpath CST.14 in the Parish of Stinchcombe shall be deleted from the map from the point where it joins Route B.4066 at Tait's Hill in a south-easterly direction to the point where it joins footpath CST.15 north-east of Clingre Farm.

Objection No. 17 by the Wotton-under-Edge Parish Council.

Map No. 13.—That an additional footpath be marked in the Parish of Wotton-under-Edge from "The Cloud" in an easterly direction along Shinbone Alley.

Map No. 13.—That an additional footpath be marked in the Parish of Wotton-under-Edge from Silver Street in a northerly direction to link up with footpath CWE.17 at the north-east end of the street known as "The Cloud".

Objection No. 18 by the Merchant Venturers.

Map No. 10.—That bridle road CNN.9 in the Parish of North Nibley shall be reclassified to a footpath.

Objection No. 19 by the Wotton-under-Edge Parish Council.

Map No. 13.—That an additional footpath shall be marked in the Parish of Wotton-under-Edge commencing at Adey's Lane near the south-west corner of Little Conygre Wood in a general north-easterly direction to join footpath CWE.15 near the north-east corner of Little Conygre Wood.

(b) IN THE RURAL DISTRICT OF EAST DEAN.

Part Objection No. 2 by the Awre Parish Council.

Map No. 19.—That an additional footpath should be marked in the Parish of Awre from the road leading to Brain's Green at a point near Martin's in a general southerly direction to link up with the existing footpaths DAW.48, 49 and 50.

Map No. 20.—That an additional footpath be marked in the Parish of Awre from the junction of footpaths DAW.20, 22 and 23 in a general south-easterly direction to Aylaws south of Guy Hall.

Maps No. 18 and 20.—That an additional footpath should be marked in the Parish of Awre from Hickman's Court in a general north-easterly direction to join footpath DAW.19.

Part Objection No. 4 by British Railways.

Map No. 19.—That footpath DAW.64 in the Parish of Awre shall be deleted from the map from County Road 40186 at a point north-west of Nibley Cottages in a general south-easterly direction to the point where it joins footpath DAW.63 north-west of Nibley Mill.

Map No. 21.—That footpath DAW.90 in the Parish of Awre shall be deleted from the map from County Road 3/25 south of Little Box in a south-easterly direction to the point where it joins DAW.87 west of Poulton Court.

Map No. 5.—That footpath DLH.43 in the Parish of Longhope shall be deleted from the map from County Road 3/34 south of Old Vicarage Farm in a north-easterly direction to the point where it joins footpath DLH.45 south of Kiln Wood.
